
**IN JANUARY, 2006, PRIOR TO THE BOARD OF DIRECTORS ELECTION OF OUR CONDOMINIUM BUILDING, ONE OF THE UNIT OWNERS, MR. LIEB KAMISCHEV, CALLED ME ON THE PHONE AND ASKED ME WHETHER I WAS JEWISH, SOME QUESTION SINCE HE HAD SEEN ME AT THE RELIGIOUS SERVICES IN CHABAD LUBAVITCH, SUNNY ISLES. 

**I AM OVER 18 YEARS OF AGE AND AM OTHERWISE COMPETENT TO TESTIFY AS TO THE MATTERS SET FORTH IN THIS AFFIDAVIT.**

**I, MARY KRystal, A UNITED STATED CITIZEN AND REGISTERED VOTER IN SUNNY ISLES BEACH, FL., RESIDING AT 301 174<sup>TH</sup> STREET, APT. 1817, SUNNY ISLES BEACH, FLORIDA 33160 DO HEREBY STATE THE FOLLOWING:**

**I HAVE BEEN ON THE BOARD OF WINSTON TOWERS 500 FOR THE PAST 2 YEARS. PRIOR TO MY RETIREMENT I WORKED 20 YEARS FOR THE SYNAGOGUE AND WAS PRESIDENT OF THE JEWISH SISTERHOOD.**

**A UNIT OWNER, LIEB KAMISHEV, STARTED TO APPROACH ME IN THE LOBBY MORE THAN TWO YEARS AGO SAYING "YOU ARE A JEWISH LADY WHY DO YOU HANG OUT WITH A NAZI?". AT FIRST I DID NOT REALIZE WHO HE WAS TALKING ABOUT. THEN REPEATEDLY, LIKE A BRAINWASH, "WHY DO YOU HANG OUT WITH THAT NAZI LIZ BRANDT" AND "YOUR HUSBAND WAS A NICE MAN BUT YOU ARE NOT BECAUSE YOU ARE HANGING OUT WITH THAT NAZI LIZ BRANDT. I WAS SHOCKED. LATER HE SAID: "DO YOU KNOW THAT HER PARENTS PUT MANY OF US JEWS IN THE OVEN" THE MOST HORRIBLE COMMENTS I HAVE EVER HEARD ABOUT AN UPSTANDING PERSON.**

**MY HUSBAND, WHO WAS A HOLOCAUST SURVIVOR BEFORE HE PASSED AWAY, LOVED LIZ. ASIDE FROM WORKING TOGETHER ON THE BOARD WE ARE NEIGHBORS, WE LIVE ON THE SAME FLOOR AND I KNOW HER FAMILY HISTORY; THAT SHE WAS BORN AND RAISED IN AMSTERDAM, HOLLAND. THAT HER FARTHER WAS PICKED UP BY THE GERMANS TO BE SENT TO A WORK CAMP. HOW THEY WERE SUBJECT TO BOMBINGS AND HUNGER. HOW SHE WORKED AS A TEENAGER FOR THE ANNE FRANK HOUSE TO RAISE MONEY. SHE WAS ALSO VERY SUPPORTIVE OF ME WHEN MY HUSBAND BECAME ILL AND LATER AFTER HE HAD PASSED AWAY.**

**I THINK THE MENTAL ANGUISH THIS MAN HAS CAUSED HER ALL THESE YEARS IS UNBEARABLE AND I HOPE ONE DAY THERE WILL BE JUSTICE.**

**BEFORE ME, THE UNDERSIGNED NOTARY PUBLIC, PERSONALLY APPEARED MARTIN FREILICH("AFFIANT") WHO, AFTER BEING DULY SWORN ACCORDING TO LAW, DEPOSES AND SAYS:**

**I AM OVER 18 YEARS OF AGE AND AM OTHERWISE COMPETENT TO TESTIFY AS TO THE MATTERS SET FORTH IN THIS AFFIDAVIT.**

**I, MARTIN FREILICH, AN 86 YEAR OLD UNITED STATES CITIZEN AND REGISTERED VOTER IN SUNNY ISLES BEACH, FL., RESIDING AT 301 174<sup>TH</sup> STREET, APT. 407, SUNNY ISLES BEACH, FLORIDA, 33160, DO HEREBY STATE THE FOLLOWING:**

**SINCE 2005, ONE OF OUR UNIT OWNERS, LIEB KAMISCHEV, HAS APPROACHED ME IN THE LOBBY, ESPECIALLY DURING ELECTION TIME, THAT LIZ BRANDT IS A NAZI AND THAT I SHOULD NOT SUPPORT HER DURING THE ELECTION.**

**I AM AN ORTHODOX JEW AND OFFICER IN THE SYNAGOGUE; I ALSO WAS IN THE BRITISH ARMY DURING WORLD WAR II. MY WIFE IS A SURVIVOR OF THE CONCENTRATION CAMPS FROM AUSWITZ AND BERGEN BELSEN. SHE KNOWS WHAT A NAZI IS. LIZ BRANDT WAS OUR CLOSE NEIGHBOR ON THE FLOOR AND HER CHARACTER IS BEYOND REPROACH.**

**FROM THE BEGINNING THAT KAMISHEV APPROACHED ME I TOLD HIM THAT HE WAS A STUPID MAN BECAUSE I KNOW THAT SHE WAS NOT EVEN BORN WHEN THE WAR STARTED. HE INSISTED THAT HER PARENTS MUST HAVE KILLED PLENTY JEWS. REPEATEDLY I TOLD HIM TO STOP THIS AND THAT SOONER OR LATER SHE WILL SUE YOU AND I WILL BE A WITNESS. HIS ANSWER WAS THAT HE WAS NOT AFRAID. SINCE I KISS LIZ WHEN I SEE HER DOWN STAIRS, HE HAS GOTTEN INTO THE HABIT OF SAYING "GO KISS YOUR NAZI". I DON'T KNOW HOW SHE HAD THE PATIENCE TO PUT UP WITH HIM AND I AM GLAD THAT SHE IS FINALLY TAKING ACTION AGAINST THIS DISGUSTING MAN, WHO IS A POISON IN OUR BUILDING.**
